76.02 HPW road closure maps

Following and email sent to the Highways department raising concerns about how clear the road closure maps are the Clerk received the following response; In light of the importance of delivering notices of emergency closures to our statutory stakeholders in a hurry, it is our policy to use Traffic Management Plans that have been provided by the applicant. People applying for an emergency closure are required to submit it to Ceredigion County Council within 2 hours of the road being closed. As soon as the Road Closure Team have been notified of an emergency closure, they will process the application as an urgent matter including showing notification emails and uploading details of the road closure on our website. Unfortunately, if I were to create our own version of these maps it would cause a delay in notification of the road closure. Please note that this is not the case for scheduled road closures. The timeframe required for processing road closure requests is set to allow adequate time for the Road Closure Team to create our own maps.
