Mae polisi yswiriant y Cyngor Cymuned i fod i gael ei adnewyddu ar 1 Mehefin, 2024. Rydym wedi derbyn y cyngor canlynol ynglyn a Toileddau Cwmtedu;

Mae'n rhaid i ni gynghori bod eich yswirwyr, Aviva, wedi ailraddio eiddo, gan geisio amlygu'r rhai sydd fwyaf mewn perygl o lifogydd. Wrth gynnal yr ymarfer hwn, daeth yn amlwg bod y toileddau cyhoeddus yng Nghwmtedu (SA44 6LQ) yn risg uchel iawn o lifogydd. O'r herwydd, mae'r premiwm adnewyddu wedi'i lwytho'n drwm i adlewyrchu hyn (mae'r premiwm ar gyfer y toileddau yn unig yn dod i £12,939.81). Yn ogystal, mae storm a llifogydd dros £7,500 bellach wedi cael eu defnyddio.

Clerc i gysylltu â'r Adran Gyfreithiol ac Ystadau i'w hysbysu'n swyddogol am hyn a gofyn a fyddai'r Cyngor Sir yn gallu rhoi'r toileddau ar ei 'bolisi bloc'. Pe bai hyn yn digwydd, byddai angen i'r Cyngor Cymuned gael dadansoddiad o gostau fel yswiriant, costau gwasanaethau cyfreithiol ac ystadau.

Mae cyfarfod brys wedi'i drefnu ddydd Mawrth 28 Mai am 7.30pm trwy Zoom i drafod y mater ymhellach. Os nad oes polisi yswiriant ar waith erbyn 31 Mai bydd y toileddau ar gau.

The Community Council's insurance policy is due for renewal on the 1st of June, 2024. We have received the following advice regarding the Public Conveniences at Cwmtedu;

We must advise that your insurers, Aviva, have carried out a re-rating of properties, looking to highlight those most at risk of flooding. When carrying out this exercise, it has become apparent that the Public Toilets at Cwmtedu (SA44 6LQ) at are extremely high risk of flooding. As such, the renewal premium has been heavily loaded to reflect this (the premium for the toilets alone comes to £12,939.81). In addition, a storm and flood excess of £7,500 also now applied.

Clerk to contact the Legal department and Estates to officially inform them of this and ask whether the County Council would be able to put the toilets on its 'block policy.' If this was the case, the Community Council would need to have a breakdown of costs such as cover, legal services costs and estates costs before making a decision.

An emergency meeting has been arranged on Tuesday the 28th of May at 7.30pm via Zoom to discuss the matter further. If no insurance policy is in place by the 31st of May the toilets will be closed.
