### 1. Expenditure under S137 Local Government Act 1972 and S2 Local Government Act 2000

Section 137(1) of the 1972 Act permits the Council to spend on activities for which it has no other specific powers if the Council considers that the expenditure is in the interests of, and will bring direct benefit to, the area or any part of it, or all or some of its inhabitants, providing that the benefit is commensurate with the expenditure. Section 137(3) also permits the Council to incur expenditure for certain charitable and other purposes. The maximum expenditure that can be incurred under both section 137(1) and (3) for the financial year 2022-23 was £8.82 per elector.

In 2022-23, the Council made payments totalling £5,441 under section 137. These payments are included within 'Other payments' in the Accounting Statement.




## Auditor General's report and audit opinion

I certify that I have completed the audit of the Annual Return for the year ended 31 March 2023 of **Llandysiliogogo Community Council**. My audit has been conducted on behalf of the Auditor General for Wales and in accordance with the requirements of the Public Audit (Wales) Act 2004 (the 2004 Act) and guidance issued by the Auditor General for Wales.

### **Audit opinion: Unqualified**

On the basis of my audit, in my opinion no matters have come to my attention to give cause for concern that, in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislative and regulatory requirements have not been met;
- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

### **Other matters and recommendations**

I draw the Council's attention to the following matters and recommendations which do not affect my audit opinion but should be addressed by the Council.

#### **Bank reconciliation**

As part of the audit, we check the bank reconciliation has been properly prepared. However, the bank reconciliation only listed a single item called unrepresented cheques. No further detail was included. Whilst we were able to conclude that the accounts are not materially mis-stated, it is important that the reconciliation is properly completed with the appropriate level of detail including a schedule of unrepresented cheques rather than a total value.

We recommend that the bank reconciliation be prepared in accordance with good practice as set out in the Practitioners' Guide.

#### **VAT**

We noted that VAT had not been properly recorded for two of the payment transactions we tested.


We recommend that VAT is separately recorded for all transactions.

### Accounting for write back of unrepresented cheques

The Council has recorded the write back of unrepresented cheques as income for the year.

We recommend that the Council follows the accounting practice specified in the Practitioners' Guide.

There are no further matters I wish to draw to the Council's attention.
